Management Team Comments and Reports:

Chief Wooten:

- Joel Higdon had asked the Chief if we would have to put together a committee for the Station 201 remodel and Chief Wooten said no since it is just a remodel it doesn't require a Committee; we will use the Facilities Bond to pay for it.
- Chief Wooten said we are getting ready to possibly hire our first female
 Firefighter. He said if she is hired there will be some remodeling that needs to be done like a separate shower area.
- Chief Wooten said he was invited to the Mayors emergency preparedness meeting he said there was lots of good information he said if the Cascadia does happen it will be far worse than anybody would expect.
- Chief Wooten said Captain Mabie will be recognized for his water rescue next week from the Cottage Grove City Council meeting.
- Chief Wooten said we received 20 application for the CERT program next step is doing criminal background checks.
- Chief Wooten said that he and Chief Solesbee got into the Risk Reduction Class so they will be leaving for that class December 7-14. He said that Chief Solesbee is currently at the Fire Marshals conference getting updated on the new Fire Code.
- Chief Wooten said we have written around 30 Fire suppression Contracts.
- Chief Wooten said we had our Civil Service meeting this week and we received 21 applications for the new FF/Paramedic Position so he pulled the top 5 candidates. He said he offered Annelies Cowan a 30-day extension to help cover through the month of October and if she gets the position she will just roll over into the open position.
- Chief Wooten said the RFP went out for the Training yard contract.
- Chief Wooten said that Fire Season ended today and that he will be out the first week of October.

Division Chief/Shift Commander Comments:

- **Chief Raade:** Chief Raade said they have been doing some training and that we do not have an arsonist in town so if you hear anybody saying that please correct them as there were some rumors.
- Chief Raade: Chief Raade said that both movie nights were successful.

Local IAFF: Captain Mabie: Captain Mabie advised the Board that an ex-employee of South Lane County Fire and Rescue was in a logging accident and is very lucky he survived his injuries his name is Matt Droege and he worked here for about 10 years.
